

- TOEFL (Computer Based) not less than 173 score or
- TOEFL (Internet Based) not less than 61 score or
- IELTS not less than 5.0 score or
- CU-TEP not less than 60 score

Only official test reports are accepted. Scores must be from within the last two years.

1.4 Earn current professional license to practice nursing approved by the Nursing Councils from their own country

1.5 Have good work experience and responsibilities

1.6 Possess good behavior without a history of unethical and immoral behavior

1.7 No underlying disease to hinder the study

1.8 Other matters based on the appointed PhD. Committee's consideration

2. Plan 2 applicant

- Earn the requirements in item 2.1.1 - 2.1.8 – except item 2.12 by having at least 1 research article (from research studies/thesis) published in international standard journal or national journal over the past 3 years.
- If the applicant graduated from master of nursing in plan B, the independent study must have adopted research methodology and must be published in international standard journal or national journal at least 2 articles over the past 5 years.

Required documents for application.

1. Original Documents

1.1 **Official, confidential transcript(s)** of Bachelor's degree and Master's degree (one for each degree). Non-English transcripts must be translated into English by a certified translator.

1.2 **English language proficiency test scores.** : an applicant must submit scores directly from the Test of English as a Foreign Language (TOEFL) administered through the Educational Testing Service to the PhD Program Officer at the

Faculty of nursing

1.3 A Medical Certificate and mental health assessment certificate (not more than 6 months).

1.4 **A letter of recommendation.** A recommendation letter of reference is required addressing your performance and judgment in the area in which you wish to study and/or your professional preparation and experience from the director of your institution.

1.5 **An approval letter of study leave** from the institution or if not approved yet, a letter for study leave has to be provided and an approval letter has to be submitted soon after receiving formal approval.

2. Certified Copies of Documents

2.1 A certified copy of certification of Bachelor's degree and Master's degree (one for each degree)

2.2 A certified copy of the abstract of the research/thesis articles published in a journal.

2.3 A certified of professional license to practice nursing approved by the appropriate Nursing Council

2.4 A certified copy of marriage certificate/change of name (if name does not match the evidence from other applications)

2.5 A relevant pre-research proposal. Applicants should submit a relevant pre research proposal (not more than 5 pages).
