1.1.7 Other matters based on the appointed Ph.D. Committee's consideration

2. For Plan 2.1 applicant

2.1 Earn the requirements in item 1.1.1 – 1.1.7—except item 1.1.2 by having at least one research article (from research studies/thesis) published / received a letter of acceptance for publication in international standard journal or national journal over the past five years.

2.2 If the applicant graduated from Master of Nursing in plan B, the independent study must have adopted research methodology and must be published /received a letter of acceptance for publication in an international standard journal or national journal. There must be at least two articles over the past five years.

Required application documents submitted to the Graduate Studies Office, Faculty of Nursing. (Incomplete applications will not be allowed an interview examination)

1. Original Documents

1.1 Official, confidential transcript(s) of Bachelor's degree and

Master's degree Non-English transcripts must be translated into English by a certified translator.

1.2 English language proficiency test scores: an applicant must submit scores directly from the Test of English as a Foreign Language (TOEFL) administered through the Educational Testing Service to the PhD Program Officer at the faculty of nursing

1.3 A medical certificate and mental health assessment certificate (not more than 6 months old).

1.4 A letter of recommendation.

1.5 An approval letter of study leave from the institution or if not approved yet, a letter for study leave has to be provided and an approval letter has to be submitted soon after receiving formal approval.

2. Certified Copies of Documents

2.1 A certified copy of certification of Bachelor's degree and Master's degree

2.2 A certified copy of the abstract of the research/thesis articles published in a journal.

2.3 A certified of professional license to practice nursing approved by the appropriate Nursing Council

2.4 A certified copy of marriage certificate/change of name (if name does not match the evidence from other applications)

3. A relevant pre-research proposal (not more than 5 pages)

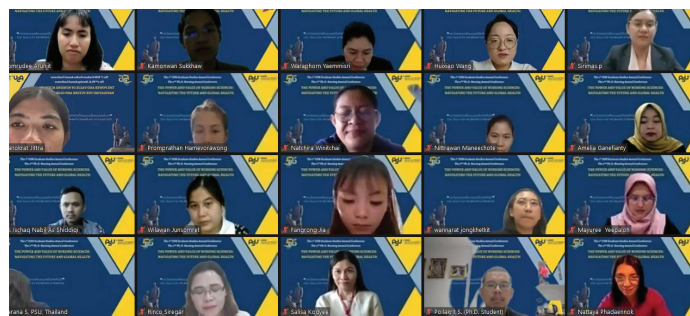

- Students require to collect research experiences 180 – 240 hours during their study.

Academic and Research Scholarships

- Research grant for thesis from the Graduate School
- Research grant for thesis from the His Royal Highness Prince Khalifa Bin Salman Al Khalif Fund on Topics Relating to the Kingdom of Bahrain
- Postgraduate scholarship from the Center of Excellence in Geriatrics, Faculty of Nursing

Tuition fee

Admission requirements

1. For plan 1.1 applicants

1.1.1 For Thai applicants: Be a graduate from an educational institution recognized by Thailand Nursing and Midwifery Council in Bachelor's degree in Nursing Science or equal and earn a Master's degree in Nursing Science in Plan A or equivalent or a Master's degree in other related fields under the consideration of the Ph.D. admission committee.

For international applicants: Master's degree in Nursing Science or equivalent, and received nursing and midwifery license from her/ his country. Otherwise, the applicant must have a certificate of registered nurse or certified by nursing regulatory authority from her/ his country

1.1.2 Have at least one research article (from research studies/thesis) published /received a letter of acceptance for publication in international standard journal or national journal in the past three years.
